

## SACI SECURITY REPORT AND CRIME STATISTICS 2015, 2016, 2017

The **Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act** requires that colleges and universities make available to current students and employees statistics for the three most recent years on the reporting of criminal offenses on campus, on certain non-campus properties, and on certain public property areas. By October 1 each year, SACI's Interim Dean of Students, Marie-Louise Lodge, posts the annual campus security report in the Policies & Guidelines section of the SACI web site (see below).

During Orientation each term, SACI students are directly notified in writing by SACI's Assistant Dean about how to access the report and can request a paper copy of it. By October of 1 each year, SACI employees are directly notified in writing by the Interim Dean of Students about how to access the report and can request a paper copy of it. A paper copy of SACI's annual campus security report may be requested by current or prospective students and employees by contacting Marie-Louise Lodge, SACI's Interim Dean of Students, or by writing to her at the following address: Studio Arts College International, Palazzo dei Cartelloni, Via Sant'Antonino, 11, 50123 Florence, Italy.

During Orientation, SACI students are advised how to behave in ways that will minimize the likelihood that they will become victims of violent or non-violent crimes. Students are additionally informed how to proceed should they become victims of an on-campus or off-campus crime. They are told to contact as soon as possible **SACI's Title IX Coordinator, Daniela Barbato**. They are informed by SACI's Title IX Coordinator about the importance of preserving evidence for the proof of a criminal offense and they are informed about reporting it to the appropriate law enforcement officials. Students are given printed information about how to contact school and police authorities at any time of the day or night.

SACI employees are encouraged to attend all Orientation presentations in which security matters are discussed in detail.

Registries of sex offenders and those convicted of other crimes are not maintained by law enforcement officials in Italy; however, local courts in Italy maintain records of all criminal proceedings, and these records are available to the public. A list of fugitives from justice, which includes those who are sex offenders, may be found on a web site maintained by the Italian Ministero degli Interni.

SACI maintains a crime log of all incidents reported to school authorities. This crime log, which lists any reported crime involving SACI students and/or employees that occurred on or adjacent to SACI's campus or in facilities leased by SACI, includes the nature, date, time, and general location of each reported crime as well as its disposition if known. Incidents are included within two business days, though certain limited information may be withheld to protect victim confidentiality, ensure the integrity of ongoing investigations, or to keep a suspect from fleeing. Only the most limited information necessary is withheld, and is subject to release once the adverse effect is no longer likely to occur. The log is publicly available during normal business hours for review by students, employees, and the general public. The information in the log remains open for sixty days and is subsequently

available within two business days of a request. Requests to review the log should be made to the Interim Dean of Students.

Whenever the SACI President considers a crime to pose an ongoing threat to SACI students and/or employees, a timely warning is issued to all members of the campus community. Reports should be made to the President of the Interim Dean of Students for the purpose of making timely warnings and/or the annual statistical disclosure of alleged criminal activity. Crime victims and/or witnesses may report crimes to school officials on a voluntary, confidential basis for inclusion in the annual disclosure of crime statistics. In such instances, it is the policy of the school to safeguard the confidentiality of such disclosures. School administrators are required to advise those making such disclosures that for on-campus disciplinary action, law enforcement activity, and/or legal prosecution to proceed, the accused has the right to know the name of the accuser and the nature of the accusations.

SACI maintains direct contact with security officers at the US Consulate in Florence and the US Embassy in Rome. All US government alerts for US citizens abroad are posted at SACI in areas frequented by SACI students, employees, and visitors.

Although SACI does not maintain a campus police force or security department, SACI employs a private security agency to check daily on security after hours at the Palazzo dei Cartelloni in Via Sant'Antonino 11 and at the SACI Jules Maidoff Palazzo for the Visual Arts in Via Sant'Egidio 14.

SACI also maintains direct contact with the Carabinieri and state police officials (Questura) in Florence. Public law enforcement officers assigned to the areas including and adjacent to SACI regularly meet with SACI administrators to report on local security issues and to check on matters involving campus security. The school administrators maintain regular contact with local police authorities who monitor and report on criminal activity at off-campus locations frequented by SACI students. During Orientation, the Interim Dean of Students reviews with SACI students, during presentations that are open to SACI employees, security issues that will help students and employees to prevent becoming victims of crime, whether on-campus, in SACI housing, or off-campus. Many of these security issues are discussed on the SACI web site on the Security Guidelines page.

Also during Orientation, SACI housing administrators meet with all students in each residence leased for student accommodation by SACI to review safety issues particular to residence in that facility.

Visitors to SACI's principal educational facility at the Palazzo dei Cartelloni and to the SACI Jules Maidoff Palazzo for the Visual Arts must identify themselves at the Reception Desk. The doors to these facilities are locked, and the Receptionist checks on all visitors before unlocking the door so that they can enter the building. Video monitors are used by the Receptionist at the Palazzo dei Cartelloni and at the SACI Jules Maidoff Palazzo for the Visual Arts to monitor activity in the street outside and to identify visitors. Employees who work at the Reception Desk have undergone emergency training in first aid and fire safety and evacuation. First aid stations are located throughout SACI facilities in areas indicated to students by their instructors.

SACI has additionally developed a comprehensive emergency contingency plan for all students and employees. A general description of these emergency contingency procedures may be found in the Policies & Guidelines section of the website.

SACI is located in the center of Florence. For the purpose of this report, "**on campus**" is defined as the following addresses:

### Description of Offenses

Offense	Definition
Murder/Non-Negligent Manslaughter	The willful killing of one human being by another.
Manslaughter by Negligence	The killing of another person through gross negligence.
Sexual Assault: Rape Fondling Incest Statutory Rape	Any sexual act directed against another person, without consent of the victim, including instances where the victim is incapable of giving consent.
Robbery	Taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.
Aggravated Assault	An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.
Burglary	The unlawful entry of a structure to commit a felony or a theft.
Motor Vehicle Theft	The theft or attempted theft of a motor vehicle.
Arson	Any willful or malicious burning or attempt to burn, with or without the attempt to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.
Hate Crimes: Race Religion Sexual Orientation Gender Gender Identity Ethnicity National Origin Disability	A criminal offense that manifests evidence that the victim was intentionally selected because of the perpetrator's bias against the victim.
Larceny	The unlawful taking, carrying, leading or riding away of property from the possession or constructive possession of another.
Simple Assault	An unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible

	internal injury, severe laceration, or loss of consciousness.
Intimidation	To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.
Destruction/Damage/Vandalism of Property	To willfully or maliciously destroy, damage, deface, or otherwise injure real or personal property without the consent of the owner or the person having custody or control of it.
Dating Violence	Violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim. The existence of such a relationship shall be determined based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship.
Domestic Violence	A felony or misdemeanor crime of violence committed— <ul style="list-style-type: none"> <li>• By a current or former spouse or intimate partner of the victim;</li> <li>• By a person with whom the victim share a child in common;</li> <li>• By a person who is cohabitating with or has cohabited with, the victim as a spouse or intimate partner;</li> <li>• By a person similarly situation to a spouse of the victim under the domestic or family violence laws of jurisdiction in which the crime of violence occurred;</li> <li>• By any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred.</li> </ul>
Stalking	Engaging in a course of conduct directed at a specific person that would cause a reasonable person to— <ul style="list-style-type: none"> <li>• Fear for the person's safety or the safety of others; or</li> <li>• Suffer substantial emotional distress</li> </ul>
Weapons Law Violations	The violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment, or use of firearms, cutting instruments, explosives, incendiary devices or other deadly weapons.
Drug Law Violations	The violation of laws prohibiting the productions, distribution and/or use of certain controlled substances and the equipment or devices utilized in their preparation and/or use. The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation or importation of any controlled drug or narcotic substance. Arrests for violations of state and local laws, specifically those relating to the unlawful possession, sale, use, growing, manufacturing and making of narcotic drugs.
Liquor Law Violations	The violation of state of local laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession or use of alcoholic beverages, not including driving under

the influence and drunkenness.
